Discussion around the difficulty of keeping up with dialysis capacity as in-centre dialysis population grows; struggling to keep up; building new capacity seems to be a slow Working on business case for large unit for 4-5 years but has been pushed back; told that the envelope for major capital investments will be closed until 2024; at that time Te Whatu Ora will be requesting what they want from the services Chris spoke to Kidney society; already have a service agreement with them to have 3 dialysis houses which counties uses for independent haemo patients who do not have the ability or house to dialysis in; Kidney Society maintain it; plan is to leverage that model and extend it to satellite dialysis; they would provide dialysis capacity (house) Counties would send the patients and nurses; Some discussion around how Kidney Society does it (ie mortgage, service agreement, Benefits are time and cost Challenge: need to do it in cost free way; Do not want new facility to be electronic; keen to keep away from any kind of international standard Concern raised about how this is why there are so many sub-standard dialysis units across Aotearoa; Andy S 2i. **Dialysis Capacity Report** Discussion around the draft version of Haemodialysis Infrastructure survey Board members acknowledged that the report was well written and highlights the state of what renal services are nationally; should go to Te Whatu Ora Key decisions to be made around publication and publicising on NRAB website; would like to call for feedback from various teams and then get it back to NRAB in May **National Clinical Networks** 2j. Mary CL Discussion around establishment of networks and how national and regional networks can support driving the changes that are needed Currently waiting for consultation to come out on the structure for hospital and specialist services – hoping for 16 March but could be pushed back 1-2 weeks; intention is to get on with consulting and have that done before the next financial year An important bit will be around how or where the resource will come from Proposal that is now with the executive leadership is that each network that is set-up should have at least a dedicated 0.4 FTE of clinical lead time which would be funded and that there is an equivalent amount for Maori professional clinical leadership; still has to be approved – in addition will be supported by up to 0.7 FTE of someone like a programme manager; other bits built in are commitment to support from improvement team and finance support, data analytics support and some comms support National networks will sit with in national hospital and specialists services team headed by Fiona Dugan, National Hospital & Service Director; one of her appointments recently has been Joanne Gibbs, National Director for System Delivery; Joanne will have the national responsibility and accountability for planned care, acute flow and for clinical networks; the intention is that networks get established, we have national leadership that's employed in in that network reporting into Joanne Paper going to ELT next week; hoping to get confirmation about what the position is around funding; hoping to then start putting together a programme on how we will progress with the different networks; will be thinking about recruitment for various roles and getting a plan in place

Intention is to get a programme plan together which is signed off and agreed by Te
