

# Aotearoa Immunisation Register

The Aotearoa Immunisation Register (AIR) is managed by Health New Zealand – Te Whatu Ora and records all immunisations that are given to people in Aotearoa New Zealand.

The AIR is used to:

- record your immunisations
- provide information to your healthcare providers about previous immunisations you have received, to assist with immunisation
- support follow up communications when immunisations are due, recommended or available, and
- help understand and manage public health risks relating to vaccine preventable diseases.

## Information recorded in the AIR

The AIR keeps a record of:

- your National Health Index number (NHI), date of birth and gender
- details about the immunisations you receive
- if you choose not to have a free immunisation that you are eligible for
- your contact person's name and contact details (if applicable).

Your name, ethnicity, contact details and healthcare provider details are not stored in the AIR, but can be accessed by authorised users of AIR through the National Health Index and National Enrolment Service systems. By using these systems, healthcare providers can link your name to your information in the AIR.

The AIR will ensure that information about your immunisations remains up to date and complete, even if you change providers or use another health service.

## How your information is used

The information collected in the AIR will only be used for the authorised purposes it was collected for. This may include:

- managing your health
- keeping you and others safe
- planning and funding health services
- other purposes, such as training healthcare professionals, supporting broader health and social services
- carrying out authorised research, including preparing and publishing statistics.

## Who can access your information

Only authorised users with login rights can access information in the AIR, including:

- people involved in managing or administering vaccines (such as vaccinators and administration staff) and other health professionals who work with you (such as your doctor and hospital staff)

- Health New Zealand staff working on vaccination programmes and vaccine-related public health campaigns, including outbreak response, contact tracing and recall programmes.

Everyone who accesses the AIR is trained to keep your personal information safe. All access to the AIR is recorded and can be audited.

Information may be shared with organisations and individuals who provide health services but do not have AIR login rights, in accordance with Data Sharing Agreements approved by Health New Zealand, such as Primary Health Organisations or Hauora Māori (Māori healthcare) providers. Information will only be shared for authorised purposes related to the AIR's functions.

## **If you want to restrict access to your immunisation information**

If you wish to limit how your immunisation information will be accessed, you can request that access to your information is restricted. However, this may mean some of the benefits of the AIR – such as direct access to your full immunisation history by those providing you with immunisation services – are not available.
