## National Occupation List (NOL) version 2.0 update

The <u>National Occupation List (NOL)</u> is an independent New Zealand-focused occupation classification. Comparable but tailored occupational classifications for Australia and New Zealand, were published by the Australian Bureau of Statistics (ABS) and Stats NZ respectively on 8 October 2024. NOL is now at version 2.0 (released 1 July 2025).

## Iwi affiliation codes V2.1.0 update

Iwi affiliation codes from the <u>Iwi and iwi-related groups statistical classification V2.1.0</u> published by Stats NZ. This version, updated on 11 March 2025, reflects the latest changes—including the renaming of 0901 Ngāti Apa (Rangitikei) to Ngā Wairiki Ngāti Apa.

### Pharmacode with ATC information

Pharmacode content is now enhanced with <u>Anatomical Therapeutic Chemical (ATC) classification</u> information to support the Ministry of Health by linking Pharmacode entries to their corresponding ATC codes.

## NZ Medicines Terminology (NZMT) July 2025 release

NZMT is our standard terminology for medicines identification, underpinning the NZ Universal List of Medicines (NZULM) and New Zealand Formulary (NZF).

We source NZMT data once per month from NZULM to enable NZHTS to serve simple NZMT code set lookups.

NZF has a fully featured FHIR API for access to NZULM/NZF content for prescribing and dispensing, medicine reconciliation and other more complex use cases.
