**Your request for official information, reference: HNZ00022121**

Thank you for your email on 10 June 2023, asking for the following information, which has been considered under the Official Information Act 1982 (the Act):

*“... what residential care facilities have contracts with Te Whatu Ora, to provide dementia care, at a level greater than level 3, in Wellington and Auckland”*

On 14 June 2023, you clarified with Te Whatu Ora that when you referred to Auckland in your request this applied to the whole of the Auckland region.

On 20 June 2023, you also confirmed that “...at a level greater than level 3” refers to residential care facilities that provide:

- Secure dementia level of care
- Secure psychogeriatric level of care

On 6 July 2023, we informed you that we needed more time to make a decision on your request.

Our response is now enclosed as Annex One.
