Your Official Information Act request, reference HNZ00008262:

On 5 December 2022, your request was transferred from the Ministry of Health to Te Whatu Ora Health - New Zealand under the Official Information Act 1982 (the Act) for response. You specifically requested information relating to the New Dunedin hospital. Please find a response to each part of your request below.

1) How much has been spent to date on architecture and planning for the new Dunedin Hospital? Please breakdown by amount spent, company paid to, and dates of payment. Is it correct that existing plans and designs for the new Dunedin Hospital have been scrapped and new ones are being designed? If so, why were the existing plans scrapped?

As at 11 January 2023, the total amount spent to date is \$58,540,144.04.

Part of your request for specific details for the date and the amount paid to each company is withheld under section 9(2)(b)(ii) of the Act, where its release would likely unreasonably prejudice the commercial position of the person who supplied the information.

2) Who were the decision makers for this? Which company/(s) designed the scrapped plans? Which company/(s) are designing the new plans? Will this have an impact on timelines for completion, if so, how much longer will the project take now? Is Minister Andrew Little aware of the reasons for the scrapping of the existing designs?

The additional funding and design changes were approved by the former Minister of Health Hon Andrew Little and the Minister of Finance Hon Grant Robinson. The following groups are responsible for the design of the new Dunedin hospital:

- Warren and Mahoney (Architecture and Health Planning)
- Holmes Consulting (Structural)
- Beca (Building Services)

The Government has approved an additional \$110 million for the New Dunedin Hospital to manage market cost escalation and to complete the project. The additional funding means the project will continue with some changes which incorporate design flexibility to increase capacity in the future. The inpatient building main construction is expected to commence in the first quarter of 2024 and construction completion is expected in 2029. The outpatient building is on track to be delivered in late 2025.
