Your request for official information, reference: HNZ00011902

Thank you for your email on 21 February 2023, asking for the following which has been considered under the Official Information Act 1982 (the Act):

"I would like to request the following information under the Official Information Act:

Part 1) The total cost of outsourced (locum) medical specialists, for each of the last five calendar years, broken down by geographic region and specialist department for Te Whatu Ora and its preceding DHB organisations.

Part 2) The total number of outsourced (locum) medical specialists used, for each of the last five calendar years, broken down by geographic region and specialist department for Te Whatu Ora and its preceding DHB organisations.

Please supply this information in a table format in an Excel spreadsheet or similar. If you withhold any information, please advise the provision in the Act and supporting reasons for the withholding".

On 22 February 2023, we clarified your request with you to which you replied with the below:

"Time period: Each of the last five calendar years. Geographical regions: Each of the former DHB boundaries. Specialist departments: Each speciality for which you have the data coded for. Preceding DHB organisations: Each of the former DHB organisations prior to Te Whatu Ora's establishment"

Due to the scope of part 1 of your request, even with your refinement, we are unable to provide you with information regarding the total cost of locum specialists for the last five years. To collate this information, we estimate it would take approximately 320-400 hours. This would result in a significant disruption to our day-to-day business. As such, your request is refused under section 18(f) of the Act as the information requested cannot be made available without substantial collation or research.

We have also considered whether Te Whatu Ora would be able to respond to your requests given extra time, or the ability to charge for the information requested. In either case, our ability to undertake our other core functions would still be impacted.

11 out of 15 districts were unable to provide the information you have requested for Part 2 of your request, due to the scope of the request. Providing you with this data and information would significantly impact the ability of our districts to carry out their other core operations. Therefore, your request is partially refused under 18(f) of the Act as the information requested cannot be made available without substantial collation or research.

The following Te Whatu Ora districts were unable to respond to Part 2 of your request:

- Waitematā
- Auckland
- Counties Manukau
- Waikato
- Bay of Plenty
- MidCentral
- Capital & Coast
- Hutt Valley
- Hawke's Bay
- Canterbury
- West Coast
- Nelson Marlborough
- Southern

The four districts that are able to provide information related to Part 2 of your request (**Appendix** 1) are:

- Lakes;
- Taranaki;
- Northland; and
- South Canterbury.

Please note, in addition to the information provided by the above Districts (Appendix 1), Te Whatu Ora is carrying out work to shift to a shared data system. At present, however, each district holds and retrieves data differently. While this work will take some time to embed, it will ensure our data system is more efficient and accessible in the future. Data integrity and availability is important to the way we work, and we make these changes with the goal of ensuring a health system that better serves all New Zealanders.

We have counted the number of individual locums who provided services in a calendar year, rather than the number of locums they may have performed in that year, e.g. if a locum worked 3 different times during 2020, this number has been recorded as 1.
